Mr Upton felt that this is illegal the Clerk disagreed and (SF) was able to access the Good Councillors Guide 2016 "Working Parties or Task & finish groups are occasionally set up for a short-term purpose. They are not subject to the strict rules that apply to a formal council meeting and do not need to be held in public." So we will meet on 19th July to sort out the running format only.
