### 823. Co-option of New Councillor

It was unanimously **AGREED** that Dean Upton should be co-opted onto the Parish Council. **DU** had completed the Declaration of Acceptance, which was countersigned by the Clerk and placed on file. Forms for Registration of Gifts and Hospitality and for the Register of Financial and Other Interests have also been completed by **DU**.

### 824. Minutes of previous meeting

a) Police

- (i) The bench seat on the Davis Kickabout required cleaning and oiling / painting. **JG** undertook to survey all the benches in the parish and obtain quotes as necessary.
