1.	Aeroplane crash	Potential road closures, traffic congestion and evacuation of individual homes	Liaise as required, including BFOBCRA if Community Centre is needed as place of safety
2.	Fallen trees blocking road	Traffic disruption	Liaise as required
3.	Fire, major	Potential road closures, traffic congestion and evacuation of individual homes	Liaise as required, including BFOBCRA if Community Centre is needed as place of safety
4.	Flooding at Pitt roundabout <sup>1</sup> and Sainsbury's roundabout <sup>2</sup>	Blocked access to major arterial routes	Liaise as required
5.	Fuel spillage or water contamination, major incident	Potential road closures and evacuation of individual homes	Liaise as required, including BFOBCRA if Community Centre is needed as place of safety
6.	Gas leak, mains	Evacuation of individual properties and potential road closure	Liaise as required, including BFOBCRA if Community Centre is needed as place of safety
7.	Pandemic	Disruption to council business, closure of council facilities, health concerns and restrictions on movement	Follow guidance from central government. Convene local support group for vulnerable residents. Use BFPC coms to update residents
8.	Power failure, major	Loss of lighting and heating to residential homes and failure of traffic lights causing traffic congestion	Liaise as required, including BFOBCRA if Community Centre is needed as place of safety
9.	Traffic incident on M3/A34/M27	Severe traffic congestion	Liaise as required
10.	Train crash	Potential road closures and traffic congestion	Liaise as required
11.	Weather, severe conditions	Possible loss of power and disruption to travel	Liaise as required, including BFOBCRA if Community Centre is needed as place of safety
